## Understanding Completion vs. Authorization certificates:

*subject to amendment, defined grace period permits you to complete original course of study.*

- Satisfactory completion of Sound-Massage Levels I, II, III-IV and any Special Seminars:
  - **Completion certificate** – **not** a professional authorization in Peter Hess® methods
  - Limited scope of application, often serves as a prerequisite for authorization.
- Satisfactory completion of Supervision (finishing) Seminar and related prerequisites:
  - **Professional authorization** – for use of "Peter Hess®" name in your practice (limited).
    - Continued use is subject to separate licensing agreement, and the following:
      - Providers are honor-bound to follow reasonable ethical and business practices.
      - Training updates may be required after a number of years (to be announced).

## Planning Your Visit:

*Tip: For best results, clear your agenda for seminar days and plan to relax during break times.*

- Unless noted, participants arrange their own lodging, meals, and travel. Whenever we offer such services in connection with a specific seminar it will be under a separate agreement.
- Accept at your own risk any offers to share rooms, food, carpool rides, etc.
- Check with us before purchasing flights or making other non-refundable arrangements.

**Expectations:**

- Participants gain certificates by engaging in all lessons and attaining minimum proficiency.
  - In the rare event a certificate is withheld, facilitator outlines a plan of support for participant to obtain certificate (repeat seminars, shadowing, practice hours, practical tests, etc.)
- Participants are expected to assess prior to registration their ability to stand for 1 hour; lift and balance/bend/reach with weight; lie prone and supine for 30 min each; receive full sound-massages; follow verbal and visual/written cues; and follow structured lessons within a group.
  - Participants agree to discuss with medical professionals any physical or psychiatric conditions or concerns representing potential difficulty or risk to themselves or others, or limits to full participation in the seminar(s) including practice exchanges with classmates.
  - Participants agree to disclose these and all related concerns to facilitator right away.
  - Facilitator will suggest accommodations that also preserve seminar integrity. If accommodation is not possible (assuming timely notice) a refund or credit may be issued.
- Participants take full responsibility for their own decisions and actions, and agree to communicate to resolve any arising difficulties clearly and immediately with the facilitator.
- Participants agree not to practice other procedures (bodywork, reiki, counseling, alt. sound methods, etc) during the seminar unless directed by or expressly permitted by the facilitator.
- The Peter Hess method is supportive and non-medical (though it may be applied by medical professionals). We do not diagnose, prevent, treat, or cure disease (no claim of “healing”).

**Cancellation and Refund Policies:**

- Some event preparation expenses are nonrefundable, so we limit cancellation as follows:
  - Phase 1: up to our posted deadline – full refund less \$25 admin fee (no fee if we cancel).
  - Phase 2: after deadline, up to 7 days prior – partial refund, reserving 50% of seminar cost.
  - Phase 3: 7 days prior or later – no refund, unless participant sends a qualified replacement participant (if fulfilled as promised, 50% will be returned after the seminar).
- Cancellation must be made in writing (get confirmation). Allow 14 days for any refund due.
- Participant may be ejected without refund for violation of terms, inappropriate or disruptive behavior, or if further involvement represents a risk to self/others/venue/equipment.
- If facilitator cancels late and no substitute instructor is available, any part of your payment not recoverable for refund will be credited in the form of a voucher good for future seminars.
- Peripheral costs are not refundable in any event (e.g. flights, meals, lodging, amenities, time).
- For cancellation circumstances not listed here, accounts are handled case-by-case.
- *We prefer to address important issues in advance, so feel free to inquire if anything seems unclear. If something comes up later, tell us right away so we can find a solution together.*
